- Duration of personal data processing /** If the Client gives the Bank its consent to process personal data for the purposes above, the Bank shall process the Client's personal data for the duration of the contractual relationship with the Client and for 1 year after the termination of such relationship. If no contractual relationship is established, the Bank shall process the Client's personal data for 1 year after giving the consent pursuant to item 2. To avoid any doubt, the consent itself pursuant to item 2 and the modification or withdrawal of the consent shall be kept by the Bank for a legitimate interest during the validity of the consent and for 10 years after its expiration.

5. **Right to withdraw the consent to process personal data** / By signing this document, the Client declares to be aware that the provision of personal data for the mentioned purposes is voluntary and that the Client can withdraw the consents above at any time. Consents that have been given may be withdrawn by repeatedly completing and signing a similar document, the model of which is available at [www.jtbanka.sk/uzitocne-informacie/osobne-udaje](http://www.jtbanka.sk/uzitocne-informacie/osobne-udaje), either by signing it directly at the Points of Sale of the Bank or by sending a signed document in electronic form at [ooou@jtbanka.sk](mailto:ooou@jtbanka.sk). If the withdrawal of consent is not signed in front of a Bank's employee, the authenticity of the Client's signature must be certified.
